### Eligibility Criteria: P. B. B. Sc. Nursing –

1. Candidate must have passed Higher Secondary or Senior Secondary or Intermediate or 10+2 or an equivalent examination recognized by the university for this purpose.
2. Candidate must have passed RGNM.

### Eligibility Criteria: M. Sc. Nursing-

1. B Sc Nursing /Post Basic B Sc Nursing with minimum of 55% aggregate marks.
2. Minimum one-year work experience after B Sc Nursing and minimum one year experience prior or after Post Basic B Sc Nursing
3. 5% relaxation of marks for Backward class categories.
4. The candidate should be a Registered Nurse and Registered midwife or equivalent with any State Nursing registration Council

### Eligibility Criteria: M.Sc. Nurse Practitioner in Critical Care (NPCC)

#### M. Sc. Nurse Practitioner in Emergency Trauma Care (NPETC)

1. Applicants must possess a registered B.Sc. Nursing with a minimum of one year clinical experience, preferably in any critical care setting prior to enrollment.
2. Must have undergone the B.Sc. in an institution recognized by the Indian Nursing Council
3. Must have scored not less than 55% aggregate marks in the B. Sc. Program.
4. In-service candidate should apply through proper channel
5. Stipend for the candidate as per university rule.
