Action Taken By Krishna Vishwa Vidyapeeth, Karad

School Of Dental Sciences, Karad To Eliminate Ragging

Our School Of Dental Sciences, Karad has followed all the directions issued by Hon'ble Supreme Court, Dental Council of India, New Delhi and University

Grants Commission. Following major actions are taken to eliminate the ragging.

- 1. The clear instructions about prohibition of ragging are mentioned in the advertisement published for the admission as well as on college website.
- 2. The regulations, punishments ingredients of ragging etc are printed in the brochure of admission.
- 3. An Anti Ragging Committee consisting of members from civil and police administration, non govt. organization, faculty members, non teaching staff members, representative of non teaching staff, junior students and senior students and representatives of the parents is formed.
- 4. The Anti Ragging Squads are appointed for maintaining vigil, oversight and patrolling functions. They are instructed to be alert and active at all times. Squads are directed to give surprise visit in hostels, Library and other common places in the campus. Also ask to furnish the detailed report to the Principal of the same.
- 5. The monitoring cell on ragging to coordinate with activities of anti ragging committee, anti ragging squads is formed.
- 6. Contact numbers, Mobile number of all committee members are displayed on hostel as well as college notice board.
- 7. The directions of Hon'ble Supreme Court are printed in the college prospectus.
- 8. An undertaking from students/Parents/guardians is obtained & filed online through www.antiragging.in/www.amanmovement.org as per the directions.

9. We have taken an undertaking as per given Proforma from all students those who

are studying in the BDS course as well as secured admission in the hostel.

10. We have taken an undertaking as per given Proforma from the parents of all

students.

11. At the commencement of the academic session, Principal had a meeting with hostel

wardens, Class representatives, General Secretary, all Head of departments,

Administrative officer, Security Incharge. The required instructions, arrangement

made to prevent ragging etc were explained.

12. The security personnel posted in the hostel are directed to work under hostel

wardens and also directed to report hostel warden immediately in case of any

problem.

13. The security is tightened specially in the hostels, library, and canteen premises.

14. Digital posters showing the rules, punishments in ragging, News paper cut outs is

displayed at hostels, Library, Canteen and other prominent places.

15. Principal has addressed a meeting of all students of BDS course on the first day of

academic year. All students are made aware about the Provisions made in the law

of ragging, possible punishments in case of ragging. And also explained about the

procedure to approach in any type of ragging or query. Explained the steps taken

by the Institute to eliminate ragging.

16. A student handbook containing of academic calendar, activities laid down by the

institute, Vision & mission of institute, list of holidays, rules and regulation of the

institute, phone number of the concerned persons etc is distributed amongst the

students.
