NOTIFICATION

The following declaration made by a resolution passed at a meeting of the Indian Nursing Council held on 5th July, 2024 under section 10 of the Indian Nursing Council Act, 1947 (48 of 1947) is hereby published, as required by Sub-section(1) of Section 15 of the said Act, namely:-

Recognition of the Ph.D Degree in Nursing qualification granted by the Krishna Institute of Medical Sciences, Deemed to be University, Karad, Maharashtra on or after 5th July, 2024.

WHEREAS, the “Krishna Institute of Medical Sciences, Deemed to be University, Karad, Maharashtra” being an authority recognized by the Government of India, Ministry of Human Resource Development vide Notification no. F.9-15/2001-U.3 dated 24.05.2005 and in exercise of the powers conferred under Section 3 of UGC Act, 1956 and also vide resolution passed at a meeting of Indian Nursing Council held on 01.07.2016 for granting Basic B.Sc. Nursing, Post Basic B.Sc. Nursing & M.Sc. Nursing qualifications has applied to the Indian Nursing Council constituted under the INC Act, 1947 (48 of 1947) as amended from time to time that the qualification granted by it in Ph. D in Nursing qualification be recognized for the purpose of the said Act from 5th July, 2024 onwards.

Now, the Executive Committee of the Council at its meeting held on 5th July, 2024 for the said purpose resolved that the following qualification when granted on or after 5th July, 2024 shall be recognized qualification for the purpose of the said Act namely: -

“Ph.D in Nursing qualification granted by the Krishna Institute of Medical Sciences, Deemed to be University, Karad, Maharashtra on or after 5th July, 2024.”
